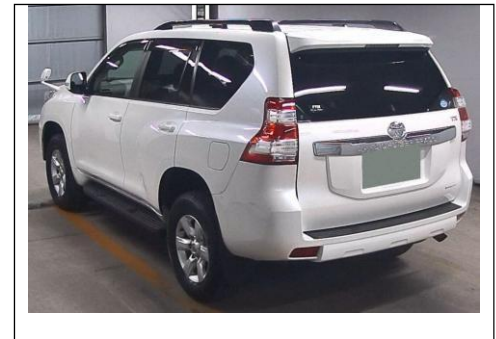

Payment Procedure

- **10%** of the total cost (**USD 3,092**) has been paid as the initial deposit as commitment fee for us to place the bid.

- **60%** of vehicle cost - (**USD 18,552**) – is payable upon confirmation of successful vehicle purchase. Prompt remittance will help to cushion us from Japanese Yen exchange rate fluctuations.

-The balance which is **30%** - (**USD 9,276**) – is Payable once you receive vehicle in Nairobi and confirm that it is as per agreement.

-The import process will take approx. 70 days. We will send you scanned copies of Roadworthiness inspection certificate (QISJ) and bill of lading approx. 5 weeks after purchase of vehicle in Japan.

Clearing/Registration

We will deliver the vehicle to buyer in Nairobi. The car will be transported from Mombasa to Nairobi via use of a car carrier i.e. will not be driven.

Buyer will sign a delivery note to acknowledge having received the vehicle.
