SALES AGREEMENT

Thanks for your purchase of your imported Motor Car :

It is our pleasure to have done business with you and look forward to serving you in the near future.
Our agreement with the abovementioned vehicle is draft to factor our mutual rights and responsibilities,
with a sale price of : [redacted]
representing total payment.

We agree to supply the said vehicle with a warranty on engine and transmission **ONLY** for
Five Thousand kilometers (5,000 KM) or Ninety (90) days in accordance with *Section 9.2 of the Motor Vehicle
Import Policy (MVIIP) (Ministry Policy 36/14)* adopted in 2014. It is our mutual understanding that upon pick-up/
delivery, your purchased vehicle has a mileage of [redacted] KM date of [redacted]
this warranty expires at [redacted] **KM** or [redacted]

It is important to note the following :

- i. As part of our agreement, we provided a detailed servicing of the engine, transmission and braking system before pick-up/delivery, in addition to providing the necessary documentation for the process of transfer, that is, a Sales Invoice and a one (1) year Certificate of Fitness.
- ii. You have the right to take a Mechanic or anyone you consider fit to advise in completing your decision for purchase. Also, all components should be checked before the unit leaves the compound or at the point of delivery.
- iii. In the event of failure in engine or transmission, you are required to contact us or our agent and get our approval before any work can be conducted on the unit. As such, no work should be done by any Independent Mechanic without consultation from Management.
- iv. Defects are NOT covered if they are caused by :
 - @ Negligence, abuse, vandalism, or by accident unrelated to the defect.
 - @ Repair attempts made by anyone other than the dealer or its representative.
 - @ Substantial change made by the purchaser/purchaser's representative to the vehicle.

Common Misunderstanding Regarding Used Car Warranty

There is no warranty on the front end parts, back end parts, nor electrical components to include bulbs, switches, Air condition coil, Radios, Navigation screen, Shock absorbers, Exhaust system, Tyres, Seal and gasket, Diagnostic sensors, etc. Therefore, all similar parts must be checked before the unit leaves our or our agent compound or at the point of delivery.
