



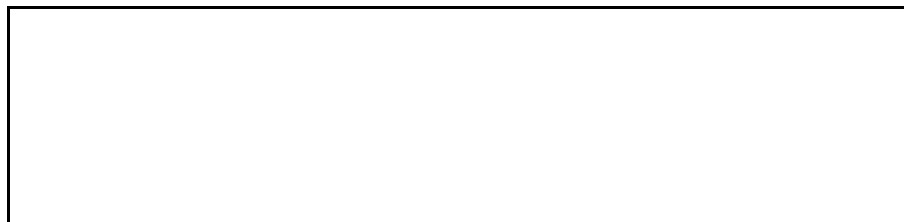

TERMS OF TRADE

1. Definitions

In these Terms of Trade, the expressions:

- (a) 'we', 'us', 'our' refer to Ferry Road Automotive Limited (the Supplier);
- (b) 'you', 'your', 'yourself' refer to the Customer.

2. Charges

Unless otherwise notified in advance by written quotation, our charges for the supply of any goods or services will be our usual charges. Details can be provided on request.

3. Payment Terms

(a) Unless otherwise agreed in writing, payment for all goods or services must be made in full at the time of supply.

4. Debt Recovery

We may recover from you all costs incurred in enforcing payment of any overdue account, including but not limited to, debt collection fees, legal costs, and court-related expenses.

5. GST and Pricing

If our charges are stated as GST exclusive, we may add GST to the amount payable.

6. Errors and Omissions

If we inadvertently fail to charge for goods or services supplied, we may invoice you separately for those items.

7. Right to Retain Possession (Lien)

- (a) We may retain possession of your vehicle under a worker's lien until all outstanding charges, including storage and penalty interest, are paid in full.
- (b) If your vehicle or property is not uplifted within one week of notification, we may charge storage fees and/or remove the vehicle from our premises.

8. Estimates and Quotations

Estimates are indicative only and are not binding. We may revise pricing if unforeseen costs arise. Written quotations are binding unless varied by mutual agreement.

9. Ownership and Risk

- (a) Ownership of any supplied goods remains with us until full payment is received.
- (b) Until ownership transfers, you must hold the goods as bailee and may not sell, modify, or pledge them without our consent.
- (c) We may repossess goods if payment is not received and you authorize us to enter premises for this purpose.

10. Availability of Parts

If we cannot source necessary parts, we may cancel the contract without liability, but you must pay for work done to date.

11. Completion Time

No specific completion date is guaranteed. Delays due to factors beyond our control may extend completion time.

12. Consumer Guarantees Act 1993

Nothing in these Terms of Trade limits your rights under the Consumer Guarantees Act 1993, except where clause 13 applies.

13. Business Use Exclusion

If goods or services are supplied for business purposes, the Consumer Guarantees Act 1993 does not apply.

14. Manufacturer Exclusion

To the extent we are a manufacturer, we exclude liability under Section 12 of the Act regarding repair facilities and spare parts.

15. Liability Limitation

- (a) We are not liable for indirect, consequential, or economic loss.
- (b) Our liability is capped at the invoice value of the goods or services supplied.

16. Customer Responsibilities

Customers must report to reception and not enter workshop areas unless authorized.

17. Warranties

All implied warranties under the Sale of Goods Act 1908 are excluded.

18. Claims and Disputes

Claims must be made in writing within 7 days of becoming aware of an issue. Claims outside this period will not be considered.

19. Default in Payment

- (a) We may suspend or cancel further supply if payment is not received.
- (b) Payments may be applied at our discretion to outstanding invoices.

20. Refunds and Credits

No refunds or credits will be given unless we agree in writing or required by law.

21. Risk Transfer

Risk in goods transfers upon leaving our premises or upon collection by you or your agent.

22. Use of Personal Information

- (a) We may use your information to provide details of our goods or services.
- (b) We may conduct credit checks as required.
- (c) You authorize us to share credit-related information with third parties.

23. Personal Property Securities Act 1999 (PPSA)

You must take any necessary steps to enable us to register our security interest in goods supplied until full payment is received.

24. Security and Guarantees

We may require additional security or personal guarantees as a condition of trade. Failure to provide such security may result in suspension of services.

25. Interest and Late Fees on Overdue Accounts

Interest at 5% per annum above our principal trading bank's base overdraft rate as well as late fees may be charged on overdue accounts.

26. Insurance and Liability

All vehicles must have comprehensive insurance. We take reasonable care but accept no liability for damage or loss, except as required by law.

By engaging with Ferry Road Automotive Limited, you agree to these Terms of Trade. **
