Therefore, IBC Japan shall not be liable for repair cost due to partial damages

- to the vehicle(s).
3. IBC Japan shall not take any responsibilities of dead battery and rust under the body caused time consumption from the delivery process.
  4. Any major faults in engine or transmission must be notified by the buyer to IBC Japan of such should be brought to IBC Japan's attention along with the quotations from the local dealers or mechanical workshops within 15-days after the vessel arrives. IBC Japan may then have a window to negotiate with the buyer for the settlements with used parts value basis, however IBC Japan will not be obliged to inspect of the vehicle.
  5. No defects or complaint will be considered by IBC Japan after the said 15-days period has past.
  6. Property of goods/cargo will be retained by IBC Japan, and will pass onto the buyer when the price payable to IBC Japan, has been paid in full.
  7. The buyer is liable to clear all outstanding balance of this vehicle before the arrival of vehicle(s) at buyer's destination. If buyer would not be able to clear all outstanding balance within one month from date of arrival, IBC Japan reserves the right to sold this vehicle(s) to any other party and the buyer will be liable to provide indemnity letter and other necessary documents to the third party.
